Our program will prepare you for an expanded role as a Legal Nurse Consultant with limitless potential for career satisfaction. **Legal Nurse Consultants** can be Registered Nurses or Advanced Practice Nurses with expertise in a variety of areas, such as med-surg, obstetrics, emergency room, quality assurance, cardiovascular, and many more. After taking the course, LNCs will be able to enhance their current practice with expert knowledge, and may also have opportunities such as reviewing medical records for an attorney, working for a hospital risk assessment office or working as an independent consultant.

After 2000 hours of practice, eligible nurse are able to sit for a certification exam and earn the legal nurse consultant credential, LNCC.

How does the in-class session work?

At the in-class session students will gain a comprehensive understanding of the medico-legal process. Students meet once a week for 5 weeks. Practicing legal nurse consultants, attorneys, insurance professionals, risk management professionals, judges, and law enforcement officers will share their expertise on the role of the LNC, the work product that is expected, evaluating personal injury or medical malpractice claims, and the roles risk management and insurance companies play in litigation and litigation prevention. Students will also learn about the court system and specifically about types of law such as no-fault law, techniques for locating and working with expert witnesses, lifecare planning, elder law and nursing home litigation.

How do I complete my internship hours?

In the second part of the course, students will complete a 168 hour internship as assigned by our internship coordinator. This internship will entail work on a case or cases with an attorney or other appropriate LNC preceptor. You will apply the principles learned in the didactic portion of the class to interpret and analyze relevant medical information related to a claim or case and formulate a comprehensive well-written document that will assist the legal process.

This can be started in the same semester you begin the didactic course, and will be completed the following semester.

When can I start?

The Legal Nurse Consultant course is offered yearly, in the fall semester. The next course is from 8 a.m. to 6 p.m. on Thursdays, Oct. 5, 12, 19, 26 and Nov. 2, 2017.

What do I need to apply?

No application is needed, simply register for the course as a non-matriculated (non-degree) student. If you are in another program at the School of Nursing, check with your advisor to see if you can use this course as an elective in your degree plan. In order to be qualified to take the course, you must have:

- A current RN license
- Nursing experience

Is financial aid available?

The Financial Aid Office provides assistance to students enrolled at the School of Nursing who are interested in obtaining alternative loans to help fund their education. Other types of aid may also be available, including employer tuition assistance (employees at the UR may be eligible to receive a substantial tuition discount), military benefits and scholarships.

What does a Legal Nurse Consultant do?

- Identify, organize and analyze pertinent medical records
- Prepare a summary of documentation in medical records
- Identify applicable standards of care in medical malpractice cases
- Identify, screen and facilitate review by expert witnesses
- Evaluate case strengths and weaknesses
- Draft or analyze medical portions of legal documents
- Evaluate causation and damages issues
- Educate attorneys and clients regarding relevant medical issues
- Identify plaintiff's future medical needs and associated costs
- Attend independent medical exams
- Serve as a nurse expert witness
- Perform cost of care estimates for long term care treatment and catastrophic case management scenarios
- Locate or prepare demonstrative evidence for trial
- Assist with preparation for and support during deposition, trial or ADR
